### **Great Texas Warrant Roundup begins March 5th**

Representatives of law enforcement agencies and courts from more than 300 jurisdictions across Texas announced combined efforts to host the 2016 Great Texas Warrant Roundup beginning Saturday, March 5th.

The roundup is designed to target thousands of defendants with traffic, parking, city ordinance, penal code, and higher charge warrants from participating jurisdictions. The focus is to bring these individuals into compliance with court orders; there are multiple options that are available to do so.

Hundreds of thousands of notices were recently mailed statewide by participating entities. Numerous counties, justices of the peace, constables, and municipalities of all sizes will participate in the roundup. It is believed to be the largest joint operation of its kind.

There are over 5,000 active warrants in the Vidor Municipal Court. Individuals are strongly encouraged to come into the court to resolve their obligations voluntarily. Defendants may call the Court office at (409) 769-7452 to be added to a Court docket to see the Judge without fear of arrest. There will also be a special “walk-in” docket held on Friday, March 4th at 9:00 a.m. for individuals with warrants. Check-in will begin at 8:30 a.m. and end at 9:00 a.m. when Court starts. Options are available for individuals who are not able to pay immediately; these include payment plans or community service for

those who qualify. Anyone who voluntarily appears at the Vidor Municipal Court to resolve their case(s) ***will not be arrested.***

Specific information as to the number of outstanding warrants, how to take care of warrants prior to arrest, and any other special roundup activities or events may be obtained by contacting the representative for each agency (list provided below).

Affected persons are urged to contact the appropriate jurisdiction or jurisdictions during the next two weeks to dispose of their cases voluntarily to avoid the inconvenience and embarrassment of arrest.
