## A. OPENING, PRESENTATIONS, AND CITIZENS COMMENTS

#### A -1. Call to order and the establishment of a Quorum.

A quorum was present, and the Regular Meeting of the Vidor City Council began at 7:00 p.m., Mayor Songe presiding.

## A -2. Invocation and Pledge to the United States Flag and the State of Texas Flag

Chris Leavins, City Attorney gave the Invocation and led the Pledge.

### **B-2.** Approval of Minutes:

A motion was made by Councilmember McGowan to approve minutes from the September 28, 2023 meeting. The motion was seconded by Councilmember Thompson and passed unanimously.

#### C. COUNCIL REGULAR AGENDA

C-1. Consideration and possible action to approve a Resolution authorizing the execution of a Contract between the City and CC Quality Inspection Service for inspection services under the CDBG-DR Voluntary Buyout Program.

Aletta Cappen addressed Council to explain that under the Voluntary Buyout Program, participants are to use the proceeds from their buyout for purchasing new homes, which are inspected for safety and construction issues before closing. A motion was made by Councilmember McGowan to approve a resolution authorizing the execution of a Contract between the City and CC Quality Inspection Service for inspection services under the CDBG-DR Voluntary Buyout Program. The motion was seconded by Councilmember Thompson and passed unanimously.

# C-2. Discussion regarding reopening applications for the Ward 5 Council Member position.

Mayor Songe explained that Councilmember Herrera is still considered a holdover in the Ward 5 seat and that if anyone wanted to apply for the Ward 5 position, applications would be opened again and brought before Council at the next meeting. Councilmember McGowan made a motion to table discussion of reopening applications for the Ward 5 councilmember position. The motion was seconded by Councilmember Thompson. The motion carried with four in favor and one opposed.

#### C-3. EXECUTIVE SESSIONS:

- a. Section 551.071 of the Texas Government Code Consultation with Attorney, regarding investigation into City Manager; and
- b. Section 551.074 of the Texas Local Government Code Personnel Matters, to deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of the City Manager, or to hear a complaint or charge against the City Manager

Mayor Songe convened the regular meeting into Executive Session at 7:06 p.m and reconvened the regular meeting at 9:14 p.m.

C-4 Consideration and possible action arising from Executive Sessions under C-3.a. and/or C-3.b., including action related to the City Manager.

Councilmember Thompson made the motion to reinstate the City Manager upon his written agreement to the terms recommended in the investigation report, including a six month probationary period. The motion was seconded by Councilmember McGowan. A roll call vote was conducted, and the motion carried unanimously.

## C-5. Consideration of Adjournment

A motion for adjournment was made by Councilmember Herrera and seconded by Councilmember McGowan. The motion carried unanimously. The regular meeting was adjourned at 9:15 p.m.
