Motion carried unanimously.

City Manager Robbie Hood told Council that the owner of the Road Ranger LLC has petitioned the City of Vidor for annexation. Hood explained that the City would benefit from the tax revenue generated by this business in exchange for the provision of City services, such as police patrols and sanitation services.
